**FAMILY COURT & URGENT FAMILY COURT  
BEFORE THE HONOURABLE JUDGE KHUMALO (Ms)  
2025 : TERM 4 : WEEK 5 (being 03 to 07 November 2025)**

1. There will be no open court appearances. The roll will be presided over utilising the MS Teams virtual platform. There will be different links for each respective day circulated through the Pretoria Attorneys Association's WhatsApp groups. Legal practitioners, and their clients as applicable, are required to log on to the MS Teams at least 30min before the commencement thereof to attend to possible technical difficulties.
2. Kindly be advised that the general Family Court Directives are to be STRICTLY complied with. An enrolment and allocation does NOT mean that the matter is considered sufficiently urgent to hear on the merits, arguments are still required addressing urgency.
3. A Practice Note and if applicable, a Joint Practise Note, comprehensively indicating the issues to be decided upon in the matter including relevant contact details of the representatives must be filed and emailed no later 12H00 on Monday, 03 November 2025. Non-Compliance will result in the matter being removed from the roll, due to papers not being in order, without the matter being called.
4. Draft Orders, both in MS Word and PDF formats, containing the relief sought as per the Notice of Motion must be both filed and emailed to the Judge's Registrar. **Draft Orders must indicate the correct date and Judge's name as follows: THE HONOURABLE MADAM JUSTICE KHUMALO.** The Representative's full details and contract particulars must appear at the bottom thereof. In the event that a Draft Order need to be amended as per the Judge's instruction, litigants are required to **BOTH** file and email such on the same day to avoid a delay.



5. No further documents are to be uploaded after the cut-off time indicated in the practice manual as read with the practice directive of this court unless with the express permission of the Honourable Judge Khumalo (Ms) this excludes updated Draft Orders. Non-Compliance will result in the matter being removed from the roll, due to papers not being in order, without the matter being called.
6. Litigants must be robed when appearing on the virtual platform, mute themselves when they are not arguing but remain visible at all times when their matter is being heard. The decorum of the court is to be maintained at all times.
7. In the event that a party wishes to enrol an Urgent Family Court matter outside of the normal time frames. The Judge's Secretary on duty presiding over the Urgent Court must be contacted on the after hours urgent phone.
8. The **Unopposed Divorces Roll is allocated to Tuesday, 04 November 2025 and will be done on paper**, no appearances are necessary unless otherwise directed by The Honourable Judge KHUMALO (M).
9. The **Urgent Family Court Roll is allocated to Tuesday, 04 November 2025** to be heard virtually and appearances is required.
10. The remainder of **the Family Court Roll is allocated to Wednesday, 05 November 2025** and appearances is required.
11. In the matters appearing under the heading; "...TIME THIS ROLL WAS FINALISED THE UNDERMENTIONED...", the applicant must ensure that by no later 12H00 on Monday, 03 November 2025 all papers filed are accessible on Caseline. Failure will result in the matter/s being removed.
